Buffer: 50 mM HEPES pH 7.1, 0.1 M NaCl, 1 mM MgCl₂, 0.1 mM ZnCl₂ containing 0.09% NaN₃
Shelf Life: 1 year from date of receipt

Production Procedures: The antibody was isolated by affinity chromatography using antigen coupled to agarose beads and conjugated to alkaline phosphatase (alkphos).

Antibody concentration was determined by extinction coefficient prior to conjugation: absorbance at 280 nm of 1.4 equals 1.0 mg of IgG. Molar enzyme:antibody protein ratio is 1:1.

By immunoelectrophoresis and ELISA this antibody reacts specifically with goat IgG and with light chains common to other goat immunoglobulins. No antibody was detected against non-immunoglobulin serum proteins. This antibody may cross react with IgG from other species.

Donkey IgG - No known toxicity for this biological material.

Bovine Serum Albumin (BSA) - No known toxicity for this biological material. (Applies only to buffers containing BSA.)

Alkaline Phosphatase - No known toxicity for this calf intestine material.

Sodium Azide (NaN₃) - AZIDE FORMS EXPLOSIVE CHEMICAL COMPOUNDS WITH LEAD AND COPPER PLUMBING. CARE MUST BE TAKEN TO WASH WASTE DOWN DRAINS WITH LARGE VOLUMES OF WATER.
LD50 oral mouse - 27 mg/kg.
