Summary & Explanation:

MACH 3 Mouse HRP-Polymer Detection is a two-step, micro-polymer detection system that provides excellent specificity and sensitivity for mouse primary antibodies. This novel biotin-free kit uses a specific probe to detect mouse monoclonal antibodies followed by a horseradish-peroxidase (HRP) labeled micro-polymer that binds to the probe. The innovative micro-polymer technology increases staining sensitivity 5 to 10 times when compared to conventional dextran polymer HRP detection kits, such as Envision +. It can be used manually and on automated stainers. The kit consists of MACH 3 Mouse Probe and Mouse Micro-polymer HRP.

Species Reactivity:

Mouse IgG heavy and light chains

Storage and Stability:

Store at 2°C to 8°C. Do not use after expiration date printed on vials. If reagents are stored under conditions other than those specified in the package insert, they must be verified by the user. Diluted reagents should be used promptly; any remaining reagent should be stored at 2°C to 8°C.

Protocol Recommendations:

Deparaffinization:

Deparaffinize slides in Slide Brite or xylene. Hydrate slides in a series of graded alcohol to water.

Peroxide Block:

Block for 5 minutes with Biocare's Peroxidazed 1.

Pretreatment Solution/Protocol:

Please refer to the respective primary antibody datasheet for recommended pretreatment solution and protocol.

Protein Block (Optional):

Incubate for 10-15 minutes at RT with Biocare's Background Sniper.

Primary Antibody:

Please refer to the respective primary antibody datasheet for incubation time.

Probe:

Incubate for 10 minutes at RT with MACH 3 Mouse Probe.

Polymer:

Incubate for 10 minutes at RT with MACH 3 Mouse HRP-Polymer.

Chromogen:

Incubate for 5 minutes at RT when using Biocare's DAB.

Counterstain:

Rinse with deionized water. Incubate for 30-60 seconds with Tacha's Automated Hematoxylin. Rinse with deionized water. Apply Tacha's Bluing solution for 1 minute.

Technical Notes:

- 1. Primary Antibody titers can be dramatically increased when using Biocare's Revival Series Diluents and Heat Retrieval Solutions. (Talk to your Biocare Sales Representative)
- MACH 3 Mouse and Rabbit detection can not be used with mouse, rat or rabbit tissues.
- 3. Do not use goat serum as a protein block. Do not use Biocare's Background Eraser or Background Terminator.
- 4. Use TBS for washing steps.

Precautions:

Troubleshooting:

Troubleshooting Guide:

No Staining

- 1. Critical reagent (such as primary antibody) omitted.
- Staining steps performed incorrectly or in the wrong order.
- 3. Heat-induced epitope retrieval (HIER) step was performed incorrectly using the wrong time, the wrong order or the wrong pretreatment.
- Insufficient amount of antigen. 4
- Secondary antibody at too low of a concentration.
- 6. Primary antibody incubation period too short.
- 7. Improperly mixed substrate and/or chromogen solution(s).

Weak Staining

- 1. Tissue is either over-fixed or under-fixed.
- 2. Primary antibody incubation time too short.
- Low expression of antigen 3
- 4. Heat-induced epitope retrieval (HIER) steps performed incorrectly using wrong time, in the wrong order, or the wrong pretreatment.
- 5. Over-development of substrate.
- Excessive rinsing during wash steps. 6.
- Omission of critical reagent. 7
- 8. Incorrect procedure in reagent preparation.
- 9. Improper procedure in test steps.

Non-specific or High Background Staining

- 1. Variable fixation time.
- 2. Endogenous alkaline phosphatase (not blocked with levamisole).
- 3. Incorrect blocking reagent used; blocker should be from same species in which the secondary antibody was raised.
- 4. Tissue may need a longer or a more specific protein block.
- Substrate is overly-developed. 5
- Tissue was inadequately rinsed. 6.
- 7. Deparaffinization incomplete.
- 8. Tissue damaged or necrotic.

Tissues Falling-Off

- Slides were not positively charged 1.
- 2. A slide adhesive was used in the waterbath
- 3. Tissue was not dried properly
- 4. Tissue contained too much fat

Specific staining too dark

- 1. Concentrated antibody not diluted out properly (being used at too high of a
- concentration)
- 2. Incubation of primary antibody, link or label too long.
