

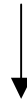

END-USER TERMS AND CONDITIONS OF USE AGREEMENT

1. **Licensed Product**
“Licensed Product” shall mean the proprietary mutation detection kits provided along with the enclosed Product Manual.
2. **Use**
The Licensed Products are strictly for User’s internal use in the area of molecular mutation detection. Transfer of resale of this product or any of its components to a 3-rd party is strictly prohibited. Any use of this Licensed Product or any of its components in a manner other than that described in the Product Manual is expressly prohibited. By opening this package the User agrees not to reverse engineer any of the Product components provided, including primers and probes and not to subject the Product reagent components or resulting output to any analysis for the purpose of creating a similar technology regardless of its indented use. The purpose of usage of Licensed Product is for research use only.
3. **Ownership**
All Licensed Products, copyrights, trademarks, trade names, trade secrets, and other proprietary rights in or related to the Licensed Products are and will remain the exclusive property of EntroGen, whether or not registered under the laws of the Territory. User will not contest EntroGen’s proprietary rights or acquire any right in the Licensed Products, except the limited use rights specified in this End-User Terms and Conditions of Use Agreement.
4. **Confidentiality**
This package contains valuable intellectual property and know-how developed by EntroGen, Inc. (Owner) and is provided herein to the purchaser’s organization (the User) for the sole purpose of molecular testing to identify target mutations using Owner’s technology and methods as listed and described in enclosed Product Manual. The User will take all reasonable precautions necessary to safeguard the confidentiality of the Licensed Product. The User will not allow the removal or defacement of any confidentiality or proprietary notice placed on items of the Licensed Products.
5. **Limitation of Liability**
ENTROGEN WILL NOT BE LIABLE, IN CONTRACT, TORT, OR OTHERWISE, FOR ANY CONSEQUENTIAL, INDIRECT, SPECIAL, OR INCIDENTAL DAMAGE, INJURY, COST, OR EXPENSE, WHETHER FORSEEABLE OR UNFORSEEABLE (INCLUDING, BUT NOT LIMITED TO, PERSONAL INJURY, DEATH, PROPERTY DAMAGE, AND LOSS OF LIFE, USE, OR PROFITS) WHICH MAY ARISE OUT OF OR IN CONNECTION WITH THIS AGREEMENT OR THE DELIVERY, USE, OR PERFORMANCE OF THE LICENSED PRODUCTS. IN NO EVENT WILL THE AGGREGATE LIABILITY WHICH ENTROGEN MAY INCUR IN ANY ACTION, WHETHER IN CONTRACT, TORT, OR OTHERWISE, EXCEED THE TOTAL AMOUNT ACTUALLY PAID TO ENTROGEN FOR THE SPECIFIC PRODUCT THAT DIRECTLY CAUSED THE DAMAGE.
6. **U.S. Export Restriction**
User acknowledges that the Licensed Products may be subject to export restrictions imposed by the U.S. Government under the Export Administration Regulations. User will (i) comply with all these restrictions; (ii) cooperated fully with EntroGen or Partner in any official or unofficial audit or inspection relating to these restrictions; and (iii) not export or re-export, directly or indirectly, the Licensed Products.
7. **Third Party Beneficiary**
User recognizes that the provisions of the End-User Terms and Conditions of Use Agreement that govern the use, ownership, confidentiality, inspection, and re-exportation of the Licensed Products, the termination and assignment of the Agreement and the limitation of liability are intended to inure to the benefit of EntroGen. User acknowledges that (i) EntroGen has the right to enforce these provisions against User, whether in its own name or the Partner’s name; (ii) EntroGen accepts this right; and (iii) Partner confirms EntroGen’s acceptance of this right by offering the End-User Terms and Conditions of Use Agreement.
