Applications:	<ul> <li>Suitable for Immunoblotting, ELISA, Immunohistochemistry, Immunomicroscopy as well as other antibody based assays using streptavidin or avidin conjugates requiring lot-to-lot consistency.</li> <li><u>Recommended Dilutions</u>: This product has been assayed against 1.0 ug of Goat IgG in a standard capture ELISA using Peroxidase Conjugated Streptavidin and ABTS (2,2'-azino-bis-[3-ethylbenthiazoline-6-sulfonic acid]) as a substrate for 30 minutes at room temperature.</li> <li>A working dilution of 1:8,000 to 1:36,000 of the reconstitution concentration is suggested for this product.</li> <li>Other applications not tested. Optimal dilutions are dependent on conditions and should be determined by the user.</li> </ul>
Specificity:	This product was prepared from monospecific antiserum by immunoaffinity chromatography using Goat IgG coupled to agarose beads followed by solid phase adsorption(s) to remove any unwanted reactivities, papain digestion and chromatographic separation. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Biotin and anti-Donkey Serum. No reaction was observed against anti-Papain or anti-Donkey IgG F(c).



## R1387B: Fab Fragment of Donkey anti-Goat IgG [H&L] -Biotin-

Storage:Store vial at 4°C prior to restoration. For extended storage reconstitute product with 50%<br/>glycerol instead of water and then aliquot contents and freeze at -20°C or below.<br/>Centrifuge product if not completely clear after standing at room temperature.<br/>This antibody is stable for one month at 4°C as an undiluted liquid.<br/>Dilute only prior to immediate use.<br/>Avoid cycles of freezing and thawing.<br/>Shelf life: One year from despatch.
