Characterization: To ensure lot-to-lot consistency, each batch of monoclonal antibody is tested to conform to characteristics of a standard reference reagent using immunofluorescence staining. Representative data are included in this data sheet.

Working Dilutions:

Flow Cytometry: $\leq 0.2 \ \mu g/10^6 \ cells$

Other Applications: Since applications vary, each investigator should determine the optimum working dilutions of the product that is appropriate for their specific needs.

Handling And Storage: The R-phycoerythrin-Cyanine 7 (R-PE-CY[™]7) conjugate is supplied as 0.1 mg in 1.0 mL of PBS/NaN3 and a stabilizing agent. Store at 2-8°C. Do not freeze! Protect conjugated forms from light. Reagents are stable for the period shown on the label if stored as directed. *Warning:* Reagents contain sodium azide. Sodium azide is very toxic if ingested or inhaled. Avoid contact with skin, eyes, or clothing. Wear eye or face protection when handling. If skin or eye contact occurs, wash with copious amounts of water. If ingested or inhaled, contact a physician immediately. Sodium azide yields toxic hydrazoic acid under acidic conditions. Dilute azide-containing compounds in running water before discarding to avoid accumulation of potentially explosive deposits in lead or copper plumbing.

BACKGROUND

Introduction: Immunoglobulin M, or Ig M for short, is a basic antibody that is produced by B cells. It is the primary antibody against A and B antigens on red blood cells. Ig M is by far the physically largest antibody in the human circulatory system. It is the first antibody to appear in response to initial exposure to antigen.
