Shelf Life: Product is stable for up to 4 weeks at 2-8°C after rehydration. For extended

storage after rehydration, add an equal volume of glycerol and store at -20°C.

heavy (γ) chains on sheep IgG

• light chains on all sheep immunoglobulins

Cross Reactivity: Based on IEP, no reactivity is observed to:

• non-immunoglobulin sheep serum proteins

Country of Origin: Donkey serum was obtained from healthy animals of US origin and under the care

of a registered veterinarian.
