Rituximab is a biosimilar directed against the extracellular domain of CD20. This product can be used as the standard in pharmacokinetic (PK) assays and constitutes the immunogen used for the anti-Idiotypic catalog number MAB9630. This antibody can be used in flow cytometry or various assay formats to measure CD20 expression.
